This document is delivered to the Administrative Director of the Procedure who later publishes it.

Annex A

Evaluation criteria

(Integrated part of minutes 1)

The Selection Committee for the public selection Announcement of selection procedure for the position of researcher at the University of Gastronomic Sciences within the project financed by the PNRR NODES PoC Academics "DMD - Digital Mediterranean Diet" - SSD AGR/15 - Food sciences and technologies - Rector's Decree n. 490/23 – 20/10/2023, in accordance with the indications in the call and on the criteria and the attribution of the scores indicated below, stipulates the methods for evaluating the qualifications.

The Selection Committee carries out the comparative evaluation of any publications based on the following criteria:

- a. originality, innovativeness, and importance of each scientific publication;
- b. consistency of each publication with the research project for which the call is announced, or with interdisciplinary topics related to it.

Based on what is indicated in the call, at the end of the evaluation of the qualifications and any scientific publications, the procedure involves an interview of the candidate in Italian and English. The interview will focus on the discussion of the qualifications, with an in-depth analysis of the topics related to the disciplinary area and to the research activity referred to in the project indicated in the call, as well as to confirm the candidate's knowledge of the English language. The interview is public.

For the evaluation of each candidate, the maximum score that can be attributed is equal to 100, of which:

- up to a maximum of 40 marks to be assigned during the evaluation of qualifications and any publications,
- up to a maximum of 60 marks to be assigned during the evaluation phase of the interview.

The test is considered passed only when at least 60 marks are obtained for the sum of the two evaluations above.

The aforementioned criteria are communicated to the Administrative Director of the procedure who will publish them, as required by the call.

The Committee decides that this comparative evaluation procedure will take place according to the following timetable:

- on 6/12/2023, at 2.25 PM, online evaluation of qualifications and publications presented by candidates for their admission to the selection;

- on 13/12/2023, at 3.30 PM, online interview with the candidates admitted to the selection.
The list of candidates admitted to the interview and the interview calendar which indicates the location and time of the interview, will be published on the internet through a notice at <https://www.unisg.it/docenti-ricerca/research-grants/> at least 7 days before the test. **The publication of the notice on the University portal is valid and equivalent to the official notification as per the law for the invitation to the tests. The absence of the candidate, for any reason, shall be considered a withdrawal from the comparative evaluation.**

The exclusion of candidates from the interview due to insufficient qualifications is adequately justified by the Selection Committee in the minutes of the selection procedure.

Candidates must produce a valid identification document to appear for the interview.

The interview will be conducted in Italian or English.

The interview is public.

Once the work has been completed, the Chairman of the Committee promptly transmits these minutes on the pre-determination of the general criteria to the Administrative Director of the Procedure, so that these criteria can be made public on the University website.
